




PACKAGE DIMENSIONS






SPATIAL DISTRIBUTION






Luminous Intensity vs. Ambient Temperature



REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS



REEL DIMENSION (units : mm)




